


Figure 1. 20-Lead Small Outline Integrated Circuit (SOIC), JEDEC MS-013, 0.300" Wide





LAND PATTERN RECOMMENDATION








Figure 2. 20-Lead Small Outline Package (SOP), EIAJ TYPE II, 5.3mm Wide






#### Figure 3. 20-Lead Thin Shrink Small Outline Package (TSSOP), JEDEC MO-153, 4.4mm Wide


